Let's be present as much as we can at the hearings or by telephone, letter writing and petition signing. Thank you!

Our First Vice State Regent, Yvette Griego, the State Chairperson for instituting Junior Catholic Daughter Courts (JCDA), is following a mandate from National Office on renewing efforts to create JCDA Courts. I am happy to announce that she is presently working on instituting a third JCDA Court in the Carlsbad area under the sponsorship of Senior Court San Jose #2252.

I want to thank the diligence and attention to responsibilities of District Deputies. This is a very important factor in whether our courts are operating according to the rules and regulations of our Order, Catholic Daughters of the Americas. To be in compliance, local courts must be diligent in arranging for a timely financial review of their financial records. The timely financial review that the District Deputy conducts is an important link to the State Regent on whether a court is on a sound financial standing. It is important to schedule a timely financial review according to the timelines set up: Financial Review shall be completed every six months - during the month of April for the period of October 1 through March 31 – and during the month of October for the period of April 1 through September 30. **(continued on page 3)**


# November 2019: Month of the Holy Souls

Financial Reviews are due at National Office by November 1 and by May 1. It is the responsibility of the Local Regent to contact the District Deputy to set up the Financial Review. Caution: Courts are to be vigilant in utilizing large amounts in Savings Account to charity. Please ensure that you are mailing your Financial Review form and dues to national office on the date indicated at the bottom of the form. I have received all the Financial Reviews at this time.

In addition, I encourage the District Deputies to complete the interviews on the form by conducting a visit to the Local courts as soon as it is convenient. I have received one such report, and I want to thank her for sending the report of visits to her courts. More information with emphasis on training and technical knowledge for our District Deputies will be provided in the next State Newsletter.

Another note of interest: The Circle of Love Reports have been mailed out to the Local Courts and I am in the process of mailing out the Circle of Love forms to the State Chairperson. I would like to impress upon the Local Regents and Local Chairpersons as well as the State Chairperson on the matter of judging the entries

on the Local level as well as the State level. Please do not use other Catholic Daughters courts or committees to judge the entries that are received. It is recommended that we should be going out into the communities and asking specific people or groups to judge the entries.

I feel that using people in the communities to judge the entries creates a view of what the Catholic Daughters of the Americas are doing within the church and community. We should also publicize our winners in our local newspapers and if at all possible, in the Catholic publication in our state, *People of God*. Use pictures of the winners whenever possible. Thank you for your hard work. Let's make a good showing at our National Convention in Dallas in July 2020.

I want to recognize the brand-new Regent, Crystal Montoya, for Local Court Saint Maurus #2601 in Loving, NM . She is outstanding for stepping up to the plate to take on the role of Regent.


#### Duties of the State Vice Regents

- ▶ You have been elected by the membership of your state:
  - to ensure that CDA grows in your state
  - to work on problems
  - to build on successes
  - to move your state forward
- ▶ Vice Regents should be aware of all problems/concerns in the court.
- ▶ Vice Regents must study the Bylaws and Tools of the Trade
- ▶ Should be assigned specific duties:
  - Assist the State Regent when requested.
  - Assume the duties of the State Regent in her absence.
  - Assume the office and duties of the State Regent or First Vice State Regent, whichever office is vacated due to resignation, removal, or permanent disability.
  - Represent the state at meetings of the National Court. Expenses may be paid by the State Court.
  - Be informed of all state and national matters.
  - Perform other such duties as may be necessary for transaction of business of the State Court or as directed by the State Regent.
